4. FIRST-AID MEASURES

Eye contact: If this chemical contacts the eyes, immediately wash (irrigate) the eyes with large amounts of water,

Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.
